C) Setting up targets on a windy day.	Actual risk of targets being blown over onto a beginner, member or volunteer helper causing injury or damage to equipment.	Beginners, members and volunteer helpers.	<p>Prior and during securing large targets, 2 adults to hold the stand at either side while a third secures the target to the ground using ties and pegs.</p> <p>For straw bosses one adult to hold the target whilst a second secures it to the ground using pegs and ties.</p>	4 Medium	A (Adequate)
D) Setting up targets in wet conditions.	Potential risk of slipping whilst handling targets.	Beginners, members and volunteer helpers.	Club captain, committee member, or the highest ranking archer present in the absence of any of the above, to decide if ground is safe to shoot on prior to setting up range.	4 Medium	A

F) Roping out over shoot area.	<p>Potential risk of members of the public wandering into over shoot area whilst shooting is taking place.</p> <p>Members of the public injuring themselves on rope due to poor visibility of rope.</p>	Members of the public who have access to the field.	<p>Over shoot area to be marked off at the minimum distance of 25 yards from left hand target (recommended by committee 50 yards) extending all the way to the back fence in a straight line.</p> <p>Minimum range length for bows shot of the fingers:</p> <ol style="list-style-type: none"> 1. For target distances up to 60 yards/meters, 110 yards. 2. For target distances over 60 yards/meters, there must be a minimum overshoot of 50 yards. <p>Minimum range length for bows shot with a mechanical release aid – 150 yards.</p> <p>All gaps in the perimeter fence to be roped off to prevent members of the public accidentally wandering into overshoot area.</p> <p>Rope to have markers placed at intervals along rope to make rope more visible to other users of the field.</p>	9 High	N

H) Carrying arrows back to waiting line.	Potential risk of falling over onto arrows causing serious or fatal injury.	Members and beginners.	<p>All beginners and members to use a quiver to carry arrows back to waiting line or (when quiver not available) to carry arrows point down.</p> <p>All members and beginners to walk at all times whilst on the range.</p>	3 Medium	N

l) Lost arrows.	<p>Potential risk of injury due to arrows being left on the field.</p> <p>Higher risk of injury due to carbon arrows being more difficult to find because they are virtually undetectable with the metal detector.</p>	All authorised and unauthorised users of the field.	<p>When an arrow has been lost all members are to assist in looking for it, using a rake, metal detector and walking in a straight line from the rear of the target. If the arrow has not been found by the end of shoot, the member whose arrow is missing must to continue searching area for as long as possible.</p> <p>If the arrow is still not found, the member is to contact a committee member to notify them, including giving the make of the fletching colour, initials and number if appropriate and any distinguishing marks/decals. The member must also record the details in lost arrow book in lock-up.</p> <p>Committee to inform rugby club liaison officer of description of lost arrow.</p> <p>Advise new members when joining club against buying carbon arrows and explain the risks so that they are able to make an informed choice when purchasing arrows.</p> <p>Advise existing members that sill want to continue using carbon arrows to insert thin aluminium foil strips to make them detectable with metal detector.</p> <p>Advise existing members to purchase ACC or aluminium arrows when arrows need replacing.</p>	<p>4 Medium</p> <p>6 High</p>	<p>A</p> <p>N</p>

Members, helpers and all authorised/unauthorised users of the field.	<p>Ensure removal of any broken arrow parts from stands and targets where possible.</p> <p>If it is not possible to remove the damaged arrow from stand/target, circle the area with marker pen (in the grey cupboard), complete an incident form and inform a committee member of the material that arrow is made from.</p> <p>Ensure that all broken arrows are taken home with the member and disposed of safely. Club arrows to be placed in container in the lock-up to be disposed of.</p> <p>Take extra care with:</p> <p>Carbon: Splinter hazard (more difficult to extract carbon splinters, higher risk of infection) Aluminium: Laceration hazard Wooden: Splinter hazard</p>	4 Medium	N

1F	First key holder to arrive at the ground should commence roping out over shoot area if able to do so. The rope is to be clearly marked using red and white tape in order to make it more visible.	Committee	Immediately	Ongoing
1F and 1G	All beginners to be taught safety protocols whilst on the beginners' course. Experienced archers to remind new members and juniors of safety procedures.	Coaches Committee	Within 6 months	Ongoing
